PARTNERS VALUE INVESTMENTS LP ANNOUNCES RENEWAL OF NORMAL COURSE ISSUER BID

TORONTO, September 30, 2019 – Partners Value Investments LP (the "Partnership") (TSX VENTURE: PVF) announced today that it received approval from the TSX Venture Exchange (the "Exchange") for the renewal of its normal course issuer bid (the "Bid") to purchase up to 3,673,741 of its non-voting equity limited partnership units (the "Equity LP Units"), representing approximately 5% of its currently outstanding Equity LP Units. The period of the Bid will remain effective from October 1, 2019 to September 30, 2020, or such earlier date that the Partnership completes its purchases.

Purchases by the Partnership pursuant to the Bid will be made by its broker, RBC Capital Markets, through the facilities of the Exchange, other designated exchanges and alternative trading systems in Canada. The price which the Partnership will pay for any Equity LP Units purchased will be the market price of the Equity LP Units at the time of acquisition. Any Equity LP Units acquired through the Bid will be cancelled. As of September 13, 2019, there were 73,474,831 Equity LP Units outstanding.

Of the 3,676,462 Equity LP units approved for purchase under the Partnership's prior normal course issuer bid that commenced on September 29, 2018 and expired on September 28, 2019, the Partnership purchased 51,200 Equity LP Units through the facilities of the TSX Venture Exchange.

The Issuer believes that, from time to time, the market price of the securities may not adequately reflect their value. In such circumstances, the Issuer believes that its outstanding securities may represent an appropriate and desirable use of its available funds.

In connection with the Bid, the Partnership will enter into an automatic purchase plan with its designated broker on or about September 30, 2019. The automatic purchase plan will allow for the purchase of Equity LP Units when the Partnership would not ordinarily be active in the market due to its own internal trading blackout periods, insider trading rules or otherwise. Outside of these periods, Equity LP Units will be repurchased in accordance with management's discretion and in compliance with applicable law.
